As the longest serving Member on the Committee, I can only commend Lesley Dickson in her continued role as representing the Judges Sub Committee. The rules, regulations and paperwork is immense but even so, has to be adhered to in order to provide accurate up to date Judges List with criteria in order to meet Kennel Club requirements. In December we held a Xmas fun day, which included a demonstration from Dogs for the Disabled, a magician for the children, games for the dogs and many, many parcels and gifts, some of which were given graciously by some of our members who were in attendance.

On the Working Scene, in September, a 12 Dog Open Breed Stake was held at Selkirk. This was followed in October with 2 events, namely a 12 Dog AV Open Stake at Duppin and then a 16 Dog AV Novice Stake in Glenalmond, Perth

Whilst well supported, it should not be forgotten the time and effort Mary Neil had to overcome to ensure these events went ahead. I am assured that, not just for this Club, to get land and judges is becoming more costly and difficult.
